Age Groups: Division 0: 6 and under Division 1: 7 and 8 Division 2: 9 and 10 Division 3: 11 and 12 Division 4: 13 and 14. **No junior high school wrestlers – club wrestlers and independents only!**

Weight classes will be determined the day of the tournament. Wrestlers may enter more than one bracket (up one weight class and/or age division). Additional registrations for the same wrestler are \$8 each and may be made the day of the tournament. **O.A.C. seeding points will be earned for all brackets/matches wrestled, but only one trophy per wrestler, for highest place won.**

Rules: Modified High School Rules: Three one-minute periods. Neutral, Choice, Choice with restarts in referee position or neutral as needed. 1 min sudden victory with 30 sec tie breaker.
