Awards: Trophy 1st place, Plaques 2 - 4th place for each weight class, per Div.(Div. 0 - V)

Rules: Modified High School, Double Elimination. Two - 1 ½ min. periods. All periods start in "up or neutral position".
After all out-of-bounds calls, wrestlers will start on their feet. Double elimination (except in championship match)
Overtime = Sudden Death (first point wins). Twelve-point difference is a Tech Fall.

Eligibility: Age as of Nov. 16, 2008 ** Bring Birth Certificate in case of a challenge of age.

Entry Fees: \$15.00 per wrestler if Pre-registered by 11/9/08 and \$20.00 the day of tournament. Early Registration is ENCOURAGED. Coaches who call in wrestlers weights will be responsible for cost of each Wrestler's registration if not Pre-registered. No Refunds!
