Weight classes will be determined the day of the tournament. Wrestlers may enter more than one bracket (up one weight class and/or age division). Additional registrations for the same wrestler are **\$8 each** and may be made the day of the tournament. O.A.C. seeding points and medals will be awarded for all brackets/matches wrestled.

Start Time: Wrestling for all divisions will start at 9:30 AM

Weigh-ins: Saturday, 2/14, 6 to 8 PM and Sunday, 2/15, 7:30 to 8:30 AM at River Valley High School

SCHOOL COACHES ONLY may send in weights by E-mail (**PREFERRED**) to Larry Smith at ChampsDad@columbus.rr.com or call them in (419-688-0268) for wrestlers on their team or in their school's kids' club before 8 PM Friday, December 26.

REGISTRATION: On-line registration at <http://www.ohioathletics.com/oacseeding.html> is **PREFERRED:** Click on the link for the **Last Chance MOAC Challenge**, then scroll down to the on-line entry form; deadline for on-line registration is **Friday, Feb. 13.**

Mail-in registration: Fill out and sign the bottom portion of this flyer and mail it to tournament director Larry Smith at 332 East Main Street, Cardington, OH 43315-1120. **Mail-in registrations must be received by Friday, February 13.**

Walk-in registration the day of the tournament is also permitted.

Saturday is the day of Mid-Ohio Athletic Conference varsity tournament. If the MOAC tournament is still in progress when you arrive for a weigh-in, please inform the ticket seller that you are there to weigh in for the Sunday youth tournament. All wrestlers must be registered, with fees paid, before they will be permitted to weigh in.

The tournament will be run on at least FOUR FULL MATS and will run quickly. If you are entering more than one weight class or age division, you may not get much rest between matches. You can take a few minutes to catch your breath and get a drink, but we will not delay the progress of the tournament for you to "rest up" between matches.

Rules: Modified High School Rules: Three one-minute periods. Start on your feet each period and after out of bounds.

Overtime: Same as old high school overtime: One minute sudden death starting from neutral; if neither wrestler scores, end the match with a 30 second sudden death period from referee's position, first score picks up or down or flip disk if no score.

All brackets will be round robin, split into two pools if more than six wrestlers and then re-combined for finals. Singlets are not mandatory (shorts & T-shirts tucked in are fine). Tournament Director reserves the right to combine or split weight classes. Proof of age must be shown if a wrestler's age is challenged (birth certificate or photo ID).

Entry Fee: \$16 on-line, \$18 mail-in, \$20 at weigh-ins. Make checks payable to MOAC Wrestling Coaches Scholarship Fund.

Awards: Medals will be awarded to the top 4 wrestlers in each weight class.
