WEIGHT CLASSES: Weight classes will be established after registration. We will be blocking weight classes based on actual weights. Every attempt will be made to keep each block within 5-6 pounds. Any bracket with three (3) wrestlers will use a round-robin format. Any bracket with two (2) wrestlers will wrestle (THERE WILL BE EVERY ATTEMPT TO BRACKET 1ST YEAR KIDS TOGETHER THIS YEAR)

FORMAT: Double Elimination. 3 1-minute periods. Ties will be decided by High School OT Rules.

*******ONLY coaches (with marked wristbands) and wrestlers will be permitted in the wrestling area. Any parent attempting to gain access to the wrestling area will cause their child to forfeit and will be escorted from the facility.**

AWARDS: Medals for 1st through 4th place finishers. **Top 3 placers in each weight class qualify for The Tournament of Champions.**

OFFICIATING: Lakota West High School Wrestlers

CONCESSIONS: All day through the completion of the final match of the day.
