Open Division: 5-6 & 13-15: Wrestling will begin at 10:00 a.m.

Open Divisions: 7-8, 9-10 & 11-12: Wrestling will begin at 1:30 p.m.

Awards: Open Division: Deluxe Trophies for Top 3 place finishers 12 and under. Top 3 finishers in the 13-15 division receive medals. Top 3 finishers in the Novice Division receive medals.
