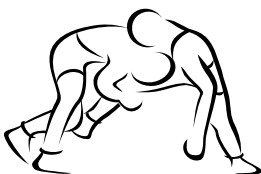


# 2009 WARREN YOUTH WRESTLING TOURNAMENT

Two 1 ½ minute periods, all neutral starts, modified high school rules apply with sudden death overtime, and 12 point lead ends the match. Tournament director reserves the right to amend tournament format if needed.

**RULES:** Age as of the day of the tournament, proof of age will be required if questioned.  
 LIMIT 2 ENTRIES PER WRESTLER. May enter more than one division or weight class.
