Weight Classes: DIVISION I – Age 8 & under (2 x 1 min. periods) 40, 45, 50, 55, 60, 65, 70, 75, Hwt (max 95)
DIVISION II – Age 9 & 10 (2 x 1½ min. periods) 50, 55, 60, 65, 70, 75, 80, 85, 90, 95, 100, 110, 120, Hwt (max 140)
DIVISION III – Age 11 & 12 (2 x 1½ min. periods) 65, 70, 75, 80, 85, 90, 95, 100, 110, 120, 130, 140, Hwt (max 175)
DIVISION IV – Age 13 & 14 (2 x 1½ min. periods) 80, 85, 90, 95, 100, 105, 110, 115, 125, 135, 145, 155, Hwt (max 205)

Middle school wrestlers may participate (O.H.S.A.A. RULING), if their school has not scrimmaged with an opposing team. Senior high wrestlers are ineligible, if they have scrimmaged against any other team. Tournament officials reserve the right to combine or create weight classes to protect the wrestler and/or promote a better tournament. **A wrestler may not enter more than one weight class.**
