Weights: **Div I Age 6 and Under:** 45, 50, 55, 60, 70, 75 and HWT (Max 90)

**Div II Age 7 and 8** : 50, 55, 60, 65, 75, 80, 90, and HWT (110)

**Div III Age 9 and 10** : 55, 60, 65, 70, 75, 85, 90, 100, 110 and HWT (Max 135)

**Div IV Age 11 and 12** : 70, 75, 80, 85, 90, 100, 105, 115, 125, 135, 150 and HWT (Max 175)

**Div V Age 13 and 14** : 80, 86, 92, 98, 104, 110, 116, 126, 132, 140, 150, 160, 175 and HWT (Max 240)

Rules: Modified High School Double Elimination: Age as of date of tournament

**Proof of Age required:** Weight classes may be combined where needed in order to provide each wrestler with multiple matches

Bout Times: Division I, II & III 2 - 1 and ½ - minute periods  
Division IV & V 2 - 2 minutes periods

Awards: Gold, Silver, and Bronze medals awarded to top 4 placers.
