**Weight Classes determined by tournament committee** - Attempt to place at least 4 wrestlers in a wt class.  
 All divisions will wrestle two 1½ minute periods with both wrestlers starting in the neutral position  
 Only Takedowns are scored. Action is immediately restarted in neutral position after each takedown.  
 6 takedown advantage results in a technical fall Overtime: Sudden Victory - determined by takedown
